# Decision making so far: challenges and strengths

Crisis leads decisions and few people are consulted (THIO operating in ambulance mode)

Fear of conflict and ethical dilemmas- frozen and can't move

Fewer people means decisions are made quicker and trust established within core

Larger community speak up at town halls but mostly “audience” and less participants

Different levels of interest, different kinds of knowledge, and different perspectives to take into account

# To make today's conversation easier

We have more time than today to decide.

Let's do our best to be intentional and concise with what we say.

Everyone is here to do good.

Everyone here brings valuable experience and information.

We are stronger together.

Conflict is a natural part of being human; how we work with it is important.

There are power differences and noticing them is ok.

We are responsible for our own actions and words.



# Core Values That Inform Our Work So Far

1. Self-determination and open mindedness
2. Trans community as stewards of trans information (we own our health info)
3. Anti-oppression
4. Anti-racism
5. Anti-transmisogyny
6. Economic justice
7. Authenticity and accountability
8. Critical hope \* needs further explanation
9. Pro sex work
10. Pro sex positivity
11. Pro/support harm reduction

## A Format for Ethical Decision Making by Michael Davis (IIT)

1. State problem (e.g. “Do I have a conflict of interest?” or even “This makes me uncomfortable”)
2. Check facts (some problems disappear upon closer examination of situation; others change radically).
3. State specifications (limits and objectives)—laws, professional code, and corporate rules to be satisfied, cost constraints (e.g. under \$200), children to feed, place in life plan (e.g. save company).
4. Develop list of at least five options (be imaginative, try to avoid “dilemma”—not “yes” or “no” but who to go to, what to say).

## A Format for Ethical Decision Making by Michael Davis (IIT)

5. Test options, using such tests as the following:

- **Harm test**—does this option do less harm than any alternative?
- **Publicity test**—would I want my choice of this option published in the newspaper?
- **Defensibility test**—could I defend my choice of this option before a future employer, a committee of my peers, or my family?
- **Reversibility test**—would I still think the choice of this option good if I were one of those adversely affected by it?
- **Virtue test**—what would I become if I choose this option often?
- **Professional test**—what might my profession's ethics committee say about this option?
- **Colleague test**—what do my colleagues/fellow community members say when I describe my problem and suggest this option as my solution?
- **Organization test**—what does the organization's ethics say about this?

## A Format for Ethical Decision Making by Michael Davis (IIT)

6. Make a tentative choice based on steps 1-5. Did you solve the problem with which you began?

7. Make final choice (after reviewing steps 1-6), act, and then ask: What could make it less likely you would have to make such a decision again?

- What precautions can you take as individual (announce policy on question, change job, etc.)?
- What can you do to have more support next time (e.g., seek future allies on this issue)?
- What can you do to change organization (e.g., suggest policy change at next meeting)?
- What can you do to change larger society (e.g. work for new policy or law)?

# How to make decisions?

**autocracy:** one person makes the decisions for everyone

**oligarchy:** a few people make the decisions for everyone

**representative democracy:** a few people are elected to make the decisions for everyone

**majority rule democracy:** the majority makes the decisions for everyone

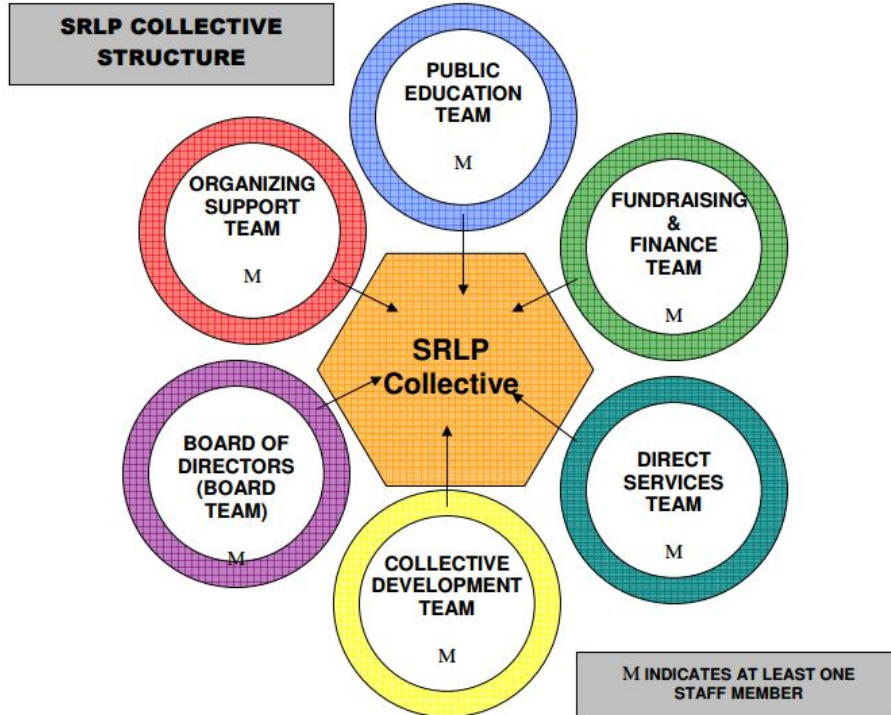
**consensus:** everyone makes the decisions for everyone

# Consensus

“A decision making process whereby decisions are reached when all members present consent to a proposal. This process does not assume everyone must be in complete agreement. When differences remain after discussion, individuals can agree to disagree, that is, give their consent by standing aside, and allow the proposal to be accepted by the group.”

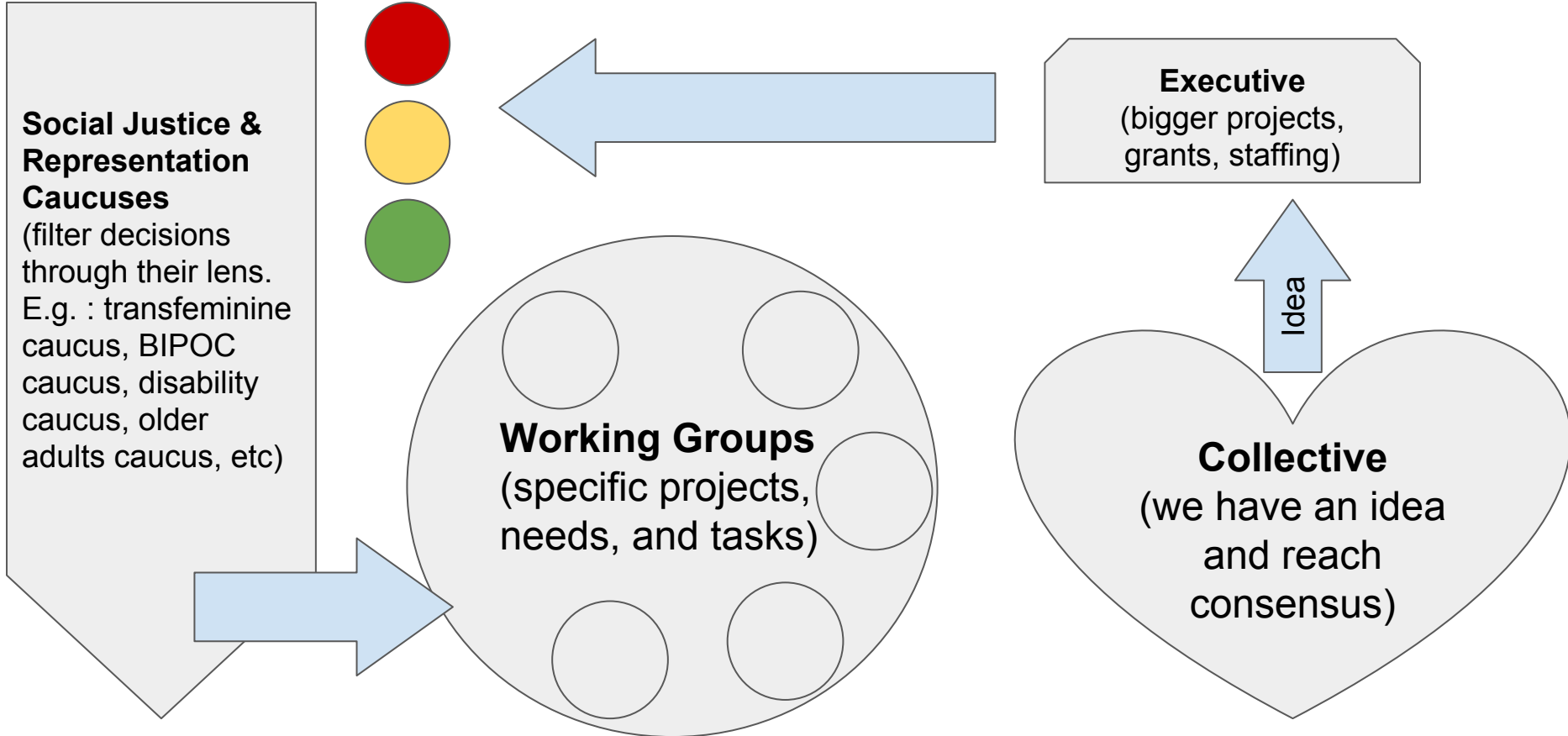
**consent:** Acceptance of the proposal, not necessarily agreement. Individuals are responsible for expressing their ideas, concerns and objections. Silence, in response to a call for consensus, signifies consent. Silence is not complete agreement; it is acceptance of the proposal.
